The project is within limits or intent of land use regulation. Subdivision complies with current zoning and town comprehensive plan. Density is far less than current zone minimum lot size. Current zoning restricts amount of forestry disturbance and/ or removal. Stormwater management systems will be compliant with current NYSDEC, NYCDEP and US Army Corps of Engineers standards and regulations. Onsite waste water treatment will be compliant with NYSDOH and NYCDEP watershed rules and regulations. Therefore the proposed action will not result in any significant adverse environmental impacts.
